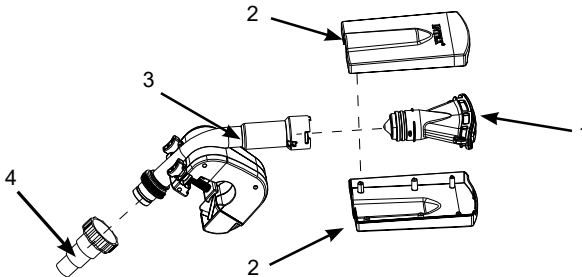

SAVE THESE INSTRUCTIONS

General

- No tools are required for the assembly.
- Fits all round and rectangular Metal Frame and Ultra Frame pools (not suitable for Easy Set, Oval and Panel pools).
- Built-in hydroelectric generator powers the LED light, no batteries or electrical connection required.
- Lights in 3 colors: red, blue and green. Preset 10 seconds between color change. Best seen at night or under low light condition.
- Pump flow rate required: 3,785-12,112 L/h (1,000-3,200 gph). System flow rate required: 2,271- 7,570 L/h (600-2000 gph).
- Make sure the pump and the pool are setup and filled with water first.
- Remove the sprayer before placing a pool cover over the pool.
- When not in use remove from the pool and store in a safe place indoors.
- For pool and filter pump problems refer to their respective owner's manual.

Setup

1. Place the sprayer clamp over the selected horizontal top beam of the metal frame pool, within reach of the filter pump return hose, and tighten the clamp screws by hand. See fig 1.

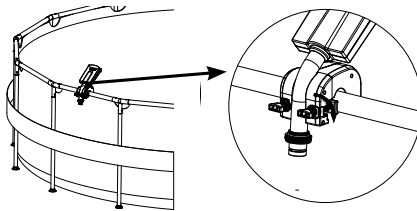

2. For filter pump with 38mm (1.5 in) hose and plunger valve:

- a) Turn off the filter pump, close the inlet plunger valve, and disconnect the pump return hose (from pump to pool) from the inlet plunger valve.
- b) Attach the pump return hose directly to the sprayer inlet. See fig 2. Turn on the filter pump.

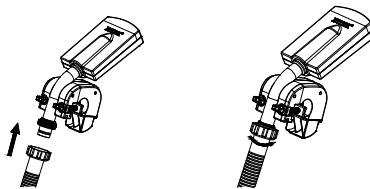

3. For filter pump with 32mm hose (1.25 in):

- a) Turn off / unplug the filter pump, cover the inlet fitting from inside of the pool to prevent water from flowing out, disconnect the pump return hose (from pump to pool) from the pool inlet fitting.
- b) Attach adaptor A (4) to the sprayer inlet, then connect the pump return hose to the adaptor A. See fig 3. Turn on / plug the filter pump.

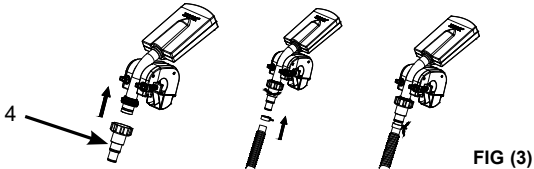

Maintenance and Long Term Storage

1. Regularly check all components for sign of damage, straining. Discard and replace damaged components immediately.
2. Use a sponge and clean water to wipe away any soil or stains.
3. Disassemble the product when the temperature drops below 5°C (41°F) by reversing the above setup instructions, drain the water out of the sprayer, and make sure all components are completely dry before storage.
4. Store the sprayer and accessories in a dry, temperature controlled, between 0° – 40°C (32° – 104°F), storage location.
5. The original packing can be used for storage.

TROUBLE	SOLUTION
LED light is off / flashing	<ul style="list-style-type: none"> • Ensure the filter pump is operating and connect the LED pool sprayer to the water return hose, see "Setup" section. • Check if the pump system flow rate is within the specified range, if the system flow rate is less than 2,271 L/h (600 gph), change pump with higher system flow rate. • Clean or replace the filter pump cartridge. If using a sand filter, ensure the sand media is clean by backwashing it. • Use a garden hose to wash the sprayer head opening, check to see if any sand or deposits in the sprayer head set. • Contact Intex Service Center.
Poor water cascade performance	<ul style="list-style-type: none"> • Use fingers to wipe away any dirt on the sprayer head opening. • The performance depends on the filter pump flow rate. If you are not satisfied with the water cascade performance, a higher flow rate filter pump is recommended.
Water spraying out of the pool	<ul style="list-style-type: none"> • The performance depends on the filter pump flow rate, change pump with lower system flow rate.

Limited Warranty

Your LED pool sprayer has been manufactured using the highest quality materials and workmanship. All Intex products have been inspected and found free of defects prior to leaving the factory. This Limited Warranty applies only to the LED pool sprayer.

The provisions of this Limited Warranty apply only to the original purchaser and is not transferable. This Limited Warranty is valid for a period of one (1) year from the date of the initial retail purchase. Keep your original sales receipt with this manual, as proof of purchase will be required and must accompany warranty claims or the Limited Warranty is invalid.

If a manufacturing defect is found within this one (1) year period, please contact the appropriate Intex Service Center listed in the separate "Authorized Service Centers" sheet. The Service Center will determine the validity of the claim. If the Service Center directs you to return the product, please carefully package the product and send with shipping and insurance prepaid to the Service Center. Upon receipt of the returned product, the Intex Service Center will inspect the item and determine the validity of the claim. If the provisions of this warranty cover the item, the item will be repaired or replaced at no charge.

Any and all disputes regarding the provisions of this Limited Warranty shall be brought before an informal dispute settlement board and unless and until the provisions of these paragraphs are carried forth, no civil action may be instituted. The methods and procedures of this settlement board shall be subject to the rules and regulations set forth by the Federal Trade Commission (F.T.C.).
